EXECUTIVE SUMMARY

A Sudanese political and human rights leader with a unique struggle spanning more than three decades, during which he transitioned from technical civil service to the core of political and rights-based work. After being forcibly dismissed from public service in 1996, he joined the opposition, becoming a prominent voice in documenting human rights violations in Darfur and a chief negotiator in the Abuja peace talks.

Crowning his experience, he returned to constitutional work under the Doha Peace Agreement, before founding the Sudanese Social Democratic Party in 2018. He currently leads his party within a civilian political coalition and is known for his anti-war stance and his call for a comprehensive political solution to restore Sudan to the path of democracy, justice, and peace.
